Advertiser understands that this agreement records the number of initial locations agreed upon, however the exact number of locations can be modified with a 30 day notice. You can add or subtract as you wish. To request a change, simply email sales@garnergroupmarketing.com

Advertiser understands that prior to ads being placed in locations that they must provide written approval of ad graphics.

Advertiser understands that once they receive their initial proof that they are able to ask up to 2 revisions. After 2 revisions, additional hourly fees apply.
